• Where there is no determination of Decision-Making Responsibility, the Centre requests that the lawyers or the parties provide written confirmation that includes the following wording: "without prejudice 'someone' has interim Decision-Making Responsibility" or "without prejudice the person agrees that the child lives with one parent and the other parent agrees to Supervised Parenting Time until the time when Decision-Making Responsibility is decided."

If CAS is involved: The Centre obtains a Family Court Order (NOT a written agreement) that clarifies Decision-Making Responsibility and Parenting Time arrangements before agreeing to provide service
