# YORK REGION SUPERVISED PARENTING TIME PROGRAM



### Intake Process

- Both parties must contact the program to initiate the intake.
- Provide a copy of one of the following documents that outlines the terms and conditions of supervised parenting time or exchange with our program, including time, date, frequency, and fee responsibility:
  - Court Order or Endorsement
  - Signed Separation Agreement
  - Signed Mediation Agreement
  - Signed Minutes of Settlement

#### Service Fees

Non-refundable Application Fee upon registration

- \$100 per family, or \$50 each party
- This fee will be credited toward Annual fee when the family begins services

**Annual Fee:** \$400 per family or \$200 each party

Subsidy is available for eligible parties

#### Service limitations

The program is **unable to provide services** in the following situations:

- During an ongoing investigation by a child protection agency
- In cases involving sexual assault charges or convictions
- Where no-contact conditions exist between parties unless an explicit exception is provided for arranging parenting time

# **Service Availability**

Our program operates within set timeframes and limited capacity. All services are scheduled based on space, staffing, and availability.

# **In-Centre Supervised Visitation**

Visits are offered 1-2 times per month per family, each lasting up to 2 hours.

The Aurora site operates 1–2 Fridays and 3 Sundays each month at the following times:

• **Fridays:** 6:00 PM – 8:00 PM

• **Sundays:** 10:00 AM – 12:00 PM and 1:00 PM – 3:00 PM

# In-Centre Supervised Exchange

Exchanges are available **1–2 Fridays and 3 Sundays each month**, scheduled based on space, staffing, and capacity.

Exchange times are as follows:

Fridays: 6:00 PM – 8:00 PM
Sundays: 10:00 AM – 3:00 PM

## **Fully Remote Supervised Virtual Parenting Time**

Virtual visits take place via **Microsoft Teams** from pre-approved locations. Each session is **30** minutes:

- 10 minutes for staff to complete device checks with each party
- 20 minutes for the virtual visit between the visiting parent and children

#### **Process Overview:**

- 1. The visiting party logs in first for a device and environment check (private, child-appropriate space).
- 2. After the check, the visiting party logs off. The residential party logs in with the children for their device check.
- 3. Once complete, the visiting party receives a new link to begin the virtual visit.

The York Supervised Parenting Time Program offers virtual visits **every other Saturday**, except during program closures (e.g., holiday weekends or scheduled staff training). In those cases, visits are rescheduled to the following Saturday.

A **mutually agreed-upon support person** may be required to assist younger children during virtual visits to help ensure their safety.
